

Terms and Conditions

- 1) **Promotion:** Visa International Service Association ("Visa") offers the promotion **"Visa Takes You to the FIFA World Cup 26™"** (the "Promotion"), subject to the rules below (the "Rules").
- 2) **Territory:** The Promotion is valid exclusively in Jamaica (the "Territory").
- 3) **Period:** The Promotion will be valid between February 20, 2026 through April 12, 2026 (the "Period").
- 4) **Participants:** The Promotion applies only to the person who meets all the following requirements (each, a "Participant"):
 - a) Adhere to these Rules.
 - b) Be of legal age (18) at the beginning of the Promotion.
 - c) Be a Visa cardholder in the Territory, not delinquent, and up to date with payments on Visa payment product(s) during the Period.
 - d) Additionally:
 - i) The payment product used belongs to you.
 - ii) Be a cardholder of the following categories of Visa payment products: Visa Credit and Debit Cards.
 - iii) Make purchases with your Visa payment products during the Promotion Period.
 - e) The Promotion is open only to people who have a locally issued Visa card

MECHANICS FOR THE PROMOTION

- The Promotion will be conducted from February 20, 2026, to April 12, 2026.
- The Promotion is open to persons 18 years and older who are Visa cardholders.
- The Promotion is limited to Visa Debit and Credit cardholders ("Cardholders") issued in Jamaica.

HOW TO ENTER

- Cardholders make purchases using their Visa Debit or Credit cards at any Visa-accepted local merchant.
- The two Cardholders who make the highest number of transactions, regardless of transaction amount, during the Promotion Period with participating Visa cards, will win the prize.

SELECTION OF WINNERS

- All qualifying Visa Debit or Credit cardholders will be evaluated based on the total number of transactions made during the Promotion Period.
- Visa will generate a report through its transaction systems to identify the Participants with the highest number of transactions.
- Visa will then share the listing with the respective authorized banking Project Officer. The Banks will manage the notification of winners and revert to Visa.
- Selected winners will be contacted primarily via telephone. If Visa or the bank is unable to reach a winner after 1 day (3 attempts per day), the next qualifying Participant (by number of transactions) will be selected as a replacement.
- Selected Winners will be instructed to claim their prize at Visa. Winners must share and present a government-issued ID (Passport or Driver's License).
- If winners do not show up to redeem their prize within 5 days of contact, the next qualifying Participant will receive the prize.

PRIZE

Each winning cardholder will receive:

- Two (2) round-trip flight tickets from the capital city of the country organizing the Promotion (Jamaica) to Toronto, Canada.
- Four (4) nights of hotel accommodation for two people at a 4-star hotel with daily breakfast included.
- Two (2) tickets to BMO Field ("Toronto Stadium") to attend the match.
- Transportation to and from the airport in the destination city.
- Amenity/gift items at Visa's discretion.

Package Exclusions:

The prize does NOT include:

- Transfers, expenses, or lodging outside the activities listed in the official itinerary.
- Personal or incidental hotel expenses (phone calls, minibar, laundry, room service), property damage, or any other expenses incurred at the hotel.
- Applicable taxes.
- Travel, medical, life, luggage, or any other type of insurance coverage.
- Immigration procedures and travel documents such as visas or any other documentation or related expenses not explicitly included.

- The Promotion is open to all Visa Debit and Credit cardholders who are Jamaican residents.
